THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$102,000 for a total estimated cost of these projects being \$937,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$102,000 with the total cost estimated to be \$937,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

2nd Aldermanic District

N. 70th St. - W. Hope Ave. to W. Congress St. and W. Congress St. - N. 68th St. to N. 70th St. (SM495210033) Installing new sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund - \$70,000). The total estimated cost of this project including the requested amount is \$770,000. This project is anticipated to be completed during the 2021 construction season.

4th Aldermanic District

N. 24th Pl. - 230'+/- S. of W. McKinley Av. to W. McKinley Av. (SM495210035) Combined sewer relay. (Nonassessable Sewer Maintenance Relay Fund - \$10,000). The total estimated cost of this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2022 construction season.

7th Aldermanic District

N. 36th St. - 310'+/- S. of W. Chambers St. to W. Chambers St. (SM495210034) Combined sewer relay. (Nonassessable Sewer Maintenance Relay Fund - \$12,000). The total estimated cost of this project including the requested amount is \$87,000. This project is anticipated to be completed during the 2022 construction season.

10th Aldermanic District

N. 60th St. - W. Vliet St. to W. Wright St. (sponsored by the City of Wauwatosa) (ST211210201) crackfilling (Nonassessable Reconstruction Paving fund -- \$10,000) The total estimated cost of this project including the requested amount is \$10,000. This project is anticipated to be completed during the 2021 construction season.
