This ordinance increases the minimum and maximum parking rates that may be charged at city-owned parking lots and structures. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 309-61-2-a-1 to 4 of the code is amended to read:

309-61. Operation of Parking Facilities.

- 2. PARKING RATES.
- a. Parking structures at MacArthur Square, 4th & Highland, 724 N. Plankinton, 535 N. Milwaukee and 1000 N. Water:
- a-1. 1st half hour [[\$0.75 to \$1.75]] >>\$1.00 to \$2.50<<.
- a-2. Daily maximum and special event [[\$1.00 to \$10.00]] >>\$3.00 to \$15.00<<.
