- Analysis -

This ordinance revises provisions of the code for purposes of correcting errors, clarifying language and eliminating obsolete provisions. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 200-33-43-i and j of the code is amended to read:

200-33. Fees.

43. PLUMBING.

i. Installation and connection of each plumbing fixture or appliance: \$8. The minimum permit fee shall be [[\$50]] >>\$55<<. The minimum permit fee for the installation of one plumbing fixture in a one or 2-family building shall be \$40.

j. Minimum fee for any inspection, reinspection, test or retest: [[\$55]] >>\$50<<.

Part 2. Section 295-75-1.5-c of the code is amended to read:

295-75. Parking Standards.

1.5. STANDARDS AND LIMITATIONS.
