Resolution determining it necessary to make various assessable public improvements at various locations. (Infrastructure Services Division)
-Analysis-

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction.
Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

1st Aldermanic District

W. Congress St. - N. 19th Pl. to N. 21st St. (870-0850-0): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

W. Eggert Pl. - N. Teutonia Ave. to N. 31st St. (870-0851-6): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

8th Aldermanic District

W. Forest Home Ave. - W. Lincoln Ave. to S. 31st St. (890-0148-7): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work.

Alley between W. Euclid Ave., W. Oklahoma Ave., S. 27th St. and S. 28th St. (E-W Leg) (880-0848-6): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

Alley between W. Hayes Ave., W. Lincoln Ave., S. 30th St. and S. 31st St. (E-W Legs) (880-0843-9): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

10th Aldermanic District

Alley between W. Melvina St., W. Vienna Ave., N. 27th St. and N. 28th St. (880-0849-1): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (2000 Paving Program)

;and, be it

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works.
