### THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements.

PUBLISHED

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

## 3rd Aldermanic District

N. Maryland Ave. - E. Locust St. to E. Linnwood Ave. (ST211030126) File Number 020286: Replace all concrete curb and gutter, widen the roadway from 35 feet to 38 feet, replace sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$32,900; Nonassessable Reconstruction Paving Fund -- \$59,400)

### 6th Aldermanic District

N. 3rd St. - W. Vienna Ave. to a point north of W. Melvina St. (ST211030119) File Number 020390: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund --\$151,100; Nonassessable Reconstruction Paving Fund -- \$72,400)

W. Melvina St. - N. 3rd St. to N. Port Washington Ave. (ST211030128) File Number 020390: Replace all concrete curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$5,100; Nonassessable Reconstruction Paving Fund -- \$81,400)

S. 27th St. (West Side) - W. Parnell Ave. to 570 feet m/l north of W. Ramsey Ave. (WT420030001/WT410031056) File Number 021277: Installing water main. (Assessable Water Fund -- \$8,700; Nonassessable Water Fund -- \$71,300)

#### 14th Aldermanic District

E. Norwich St. - A point east of S. Kansas Ave. to S. Alabama Ave. (Sponsored by the City of St. Francis) (ST211030140) File Number 021622: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$3,000; Nonassessable Reconstruction Paving Fund -- \$3,000)

Whereas, The report of the Commissioner of Public Works has been filed with the City Clerk; and

Whereas, Notices have been sent to all interested persons and public hearings held; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That projects: N. Maryland Ave. (ST211030126), N. 3rd St. (ST211030119), W. Melvina St. (ST211030128), and S. 27th St. (WT420030001) will be billed after January 1, 2005, and project E. Norwich St. (ST211030140) be billed after January 1, 2006, but not before 12 months after the project contract has been completed; and, be it
