This ordinance lists those election wards which are assigned to each of the 15 aldermanic districts commencing in June 2012. This file utilizes wards as amended through file number 111651, based on the Wisconsin State Legislature boundaries as adjusted by Baldus v. Baldwin, 11-cv-562, U.S. District Court for the Eastern District of Wisconsin.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 301-2 of the code is amended to read:

**301-2. Aldermanic District Boundaries.** Effective with the 2012 spring primary election, the territory within the limits of the city of Milwaukee shall be divided into 15 aldermanic districts which shall be comprised of the following election wards, as described in resolution file number 111651:
