THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$563,000 for a total estimated cost of these projects being \$11,172,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$563,000 with the total cost estimated to be \$11,172,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

2nd Aldermanic District

N. 76th St. - 290 feet south of W. Grantosa Dr. to W. Medford Ave. (SM495150084): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$171,000. This project is anticipated to be completed during the 2016 construction season.

4th Aldermanic District

N. Emmer Ln. at 400 feet south of W. Mt. Vernon Ave. (WT410150780): Water repair work.

(Nonassessable Water Fund Budget Line 5010 -- \$7,000; Nonassessable Water Fund Budget Line 6410 -- \$8,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2015 construction season.

W. Juneau Ave. - N. 27th St. to N. 28th St. (SM495150060): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$265,000. This project is anticipated to be completed during the 2016 construction season.

E. Michigan St. - N. Jackson St. to N. Van Buren St. (SM495150078): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$28,000. This project is anticipated to be completed during the 2016 construction season.

E. Michigan St. - N. Milwaukee St. to N. Water St. (SM495150077): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$141,000. This project is anticipated to be completed during the 2016 construction season.

N. Prospect Ave. - E. Wells St. to E. Kilbourn Ave. (SM495150057): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$112,000. This project is anticipated to be completed during the 2016 construction season.

W. State St. - N. 34th St. to N. 35th St. (SM495150081): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$35,000. This project is anticipated to be completed during the 2016 construction season.

N. Van Buren St. - E. Wisconsin Ave. to a point south of E. Michigan St. (SM495150079): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2016 construction season.

W. Vliet St. - N. 13th St. to N. 14th St. (SM495150055): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2016 construction season.

N. 4th St. - W. State St. to W. Juneau Ave. (WT410160781): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$22,000; Nonassessable Water Fund Budget Line 6410 -- \$23,000). The total estimated cost for this project including the requested amount is \$750,000. This project is anticipated to be completed during the 2016 construction season.

N. 12th St. - 200 feet north of W. Wells St. to W. Kilbourn Ave. (SM495150086): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$67,000. This project is anticipated to be completed during the 2016 construction season.

N. 15th St. - W. Highland Blvd. to W. Juneau Ave. (SM495150092): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2016 construction season.

N. 17th St. - W. Kilbourn Ave. to W. Highland Ave. (SM495150063): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$619,000. This project is anticipated to be completed during the 2016 construction season.

N. 18th St. - 200 feet south of W. Highland Ave. to W. Highland Ave. (SM495150091): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$65,000. This project is anticipated to be completed during the 2016 construction season.

N. 19th St. - W. McKinley Ave. to W. Vliet St. (SM495150073): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$507,000. This project is anticipated to be completed during the 2016 construction season.

N. 21st St. - W. State St. to W. Highland Ave. (SM495150071): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$72,000. This project is anticipated to be completed during the 2016 construction season.

N. 22nd St. - W. State St. to W. Highland Ave. (SM495150064): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$82,000. This project is anticipated to be completed during the 2016 construction season.

N. 23rd St. - W. State St. to W. Highland Ave. (SM495150070): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$57,000. This project is anticipated to be completed during the 2016 construction season.

N. 25th St. - W. McKinley Ave. to W. Juneau Ave. (SM495150087): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$112,000. This project is anticipated to be completed during the 2016 construction season.

#### 4th and 15th Aldermanic Districts

N. 27th St. and W. Vliet St., N. 27th St. and W. Cherry St. (Intersections) (SM495150059): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$109,000. This project is anticipated to be completed during the 2016 construction season.

#### 6th Aldermanic District

N. 6th St. - W. Vine St. to W. Brown St. (SM495150083): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$131,000. This project is anticipated to be completed during the 2016 construction season.

N. 10th St. and easement north of N. 10th St. (Ext'd) - W. Galena St. (Ext'd) to south of W. Vine St. (Ext'd) (SM495150075): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$239,000. This project is anticipated to be completed during the 2016 construction season.

#### 8th Aldermanic District

W. Lincoln Ave. - S. 26th St. to S. Layton Blvd. (SM495150080): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$74,000. This project is anticipated to be completed during the 2016 construction season.

S. 25th St. - W. Greenfield Ave. to W. Orchard St. (SM495150065): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2016 construction season.

#### 8th and 12th Aldermanic Districts

W. Greenfield Ave. - S. 17th St. to S. 26th St. (SM495150066): Combined sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$1,166,000. This project is anticipated to be completed during the 2016 construction season.

W. Lincoln Ave. - S. 20th St. to S. 21st St. (SM495150076): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$222,000. This project is anticipated to be completed during the 2016 construction season.

#### 10th Aldermanic District

N. 55th St. - W. Lloyd St. to W. Garfield Ave. (SM495150052): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$56,000. This project is anticipated to be completed during the 2016 construction season.

N. 61st St. - W. St. Paul Ave. to 250 feet north of W. St. Paul Ave. (SM495150072): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$53,000. This project is anticipated to be completed during the 2016 construction season.

#### 10th and 15th Aldermanic Districts

W. Lloyd St. - N. 48th St. to N. 53rd St. (SM495150056): Combined sewer lining. (Nonassessable

Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$1,006,000. This project is anticipated to be completed during the 2016 construction season.

N. 51st St. - W. Lloyd St. to W. Garfield Ave. (SM495150053): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$189,000. This project is anticipated to be completed during the 2016 construction season.

#### 12th Aldermanic District

W. Lincoln Ave. - S. 7th St. to S. 8th St. (SM495150082): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$66,000. This project is anticipated to be completed during the 2016 construction season.

#### 14th Aldermanic District

S. Kinnickinnic Ave. - 100 feet north of E. Malvern Pl. to E. Ohio Ave. (SM495150058): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$41,000. This project is anticipated to be completed during the 2016 construction season.

#### 15th Aldermanic District

W. Center St. - N. 25th St. to N. 26th St. (SM495150088): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$117,000. This project is anticipated to be completed during the 2016 construction season.

W. Galena St. - N. 26th St. to N. 30th St. (SM495150061): Combined sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$778,000. This project is anticipated to be completed during the 2016 construction season.

W. Lloyd St. (Ext'd) - South of W. Fond du Lac Ave. to N. 20th St. (SM495150051): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$273,000. This project is anticipated to be completed during the 2016 construction season.

W. North Ave. - N. Teutonia Ave. to N. 14th St. (SM495150067): Combined sewer lining and repair. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$225,000. This project is anticipated to be completed during the 2016 construction season.

N. Sherman Blvd. - W. Lisbon Ave. to W. North Ave. (SM495150054): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$104,000. This project is anticipated to be completed during the 2016 construction season.

N. Teutonia Ave. - W. North Ave. to a point 100 feet north of W. North Ave. (SM495150068): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2016 construction season.

W. Walnut St. - N. 26th St. to N. 27th St. (SM495150062): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$1,029,000. This project is anticipated to be completed during the 2016 construction season.

W. Wright St. - N. 11th St. to N. 15th St. (SM495150069): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$595,000. This project is anticipated to be completed during the 2016 construction season.

N. 20th St. - W. North Ave. to W. Wright St. (SM495150074): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$895,000. This project is anticipated to be completed during the 2016 construction season.

N. 26th St. - W. Center St. to 300 feet north of W. Center St. (SM495150089): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$86,000. This project is anticipated to be completed during the 2016 construction season.
