## THE CHAIR

A substitute ordinance relating to registration of domestic partners of city employes. 111-3-10 cr

This ordinance creates a separate registry for the domestic partners of city employes. Their

domestic partnerships are identical to those currently created under chapter 111 of the code, with the following exceptions:

- 1. Partnerships are to be applied for in person at the department of employe relations.
- 2. The department of employe relations is responsible for verifying all information provided by those seeking to register a domestic partnership involving city employes.
- 3. Those seeking to register a domestic partnership involving city employes are required to declare that they possess at least 3 of the conditions for domestic partnership given in chapter 111.
- 4. Domestic partnerships involving city employes need not be between people of the same sex.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 111-3-10 of the code is created to read:

### 111-3. Domestic Partnership Registration.

- **10.** REGISTRATION OF DOMESTIC PARTNERS OF CITY EMPLOYES. The city clerk shall maintain a separate registry for the domestic partners of city employes. City employes may register a domestic partnership under the same conditions and terms as contained in this chapter, except that:
- a. Application under sub. 2 shall be made in person in the department of employe relations.
- b. Subsection 3-e shall not apply.
- c. Applicants shall declare that they possess at least 3 of the conditions of domestic partnership listed under sub. 5.
- d. Verification made under sub. 7-a shall be performed by the department of employe relations. The department may require such reasonable documentation as may be necessary to verify the claims make by those seeking to register a domestic partnership and its investigation shall not be limited by sub. 7-c.
