Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$151,000 for a total estimated cost of these projects being \$6,210,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$151,000 with the total cost estimated to be \$6,210,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

3rd Aldermanic District

E. Bradford Ave. - N. Frederick Ave. to N. Maryland Ave. (SM495170046): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2018 construction season.

6th Aldermanic District

N. 12th St. - W. Atkinson Ave. to W. Abert Pl. (SM495170047): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this

project including the requested amount is \$123,000. This project is anticipated to be completed during the 2018 construction season.

#### 10th Aldermanic District

N. 79th St. - W. Mt. Vernon Ave. to the Honey Creek Outfall (SM499170106): Relaying storm sewer. (Nonassessable Storm Water Quality Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$72,000. This project is anticipated to be completed during the 2018 construction season.

N. 80th St. - W. Mt. Vernon Ave. to the Honey Creek Outfall (SM499170107): Relaying storm sewer. (Nonassessable Storm Water Quality Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$86,000. This project is anticipated to be completed during the 2018 construction season.

#### 11th Aldermanic District

W. Sumac Pl. (Ext'd) - W. Kinnickinnic River Pkwy. to the Kinnickinnic River Outfall (SM499170105): Relaying storm sewer. (Nonassessable Storm Water Quality Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$51,000. This project is anticipated to be completed during the 2018 construction season.

#### 13th and 14th Aldermanic Districts

W. Dakota St. - S. 11th St. to S. 16th St. (SM495170043): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$3,624,000. This project is anticipated to be completed during the 2018 construction season.

#### 14th Aldermanic District

W. Dakota St. - S. 6th St. to S. 11th St. (SM495170041): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$767,000. This project is anticipated to be completed during the 2018 construction season.

W. Montana St. - S. 9th Pl. to 120 feet west of S. 12th St. (SM495170045): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$406,000. This project is anticipated to be completed during the 2019 construction season.

S. 6th St. - W. Dakota St. top 180 feet south of W. Dakota St. (SM495170040): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$193,000. This project is anticipated to be completed during the 2018 construction season.

S. 7th St. - W. Montana St. to W. Dakota St. (SM495170042): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$341,000. This project is anticipated to be completed

during the 2018 construction season.

S. 11th St. - W. Montana St. to W. Dakota St. (SM495170044): Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$462,000. This project is anticipated to be completed during the 2019 construction season.

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
