Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$238,000 for a total estimated cost of these projects being \$7,354,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$238,000 with the total cost estimated to be \$7,354,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

2nd and 9th Aldermanic Districts

W. Custer Ave. - N. 58th St. to N. 60th St. (SM495060049): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000) The total estimated cost for this project including the requested amount is \$198,000. This project is anticipated to be completed during the 2007 construction season.

3rd Aldermanic District

E. Newberry Bl. (South Side) - N. Summit Ave. to N. Shepard Ave. (SM495060059): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000) The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2007 construction season.

4th Aldermanic District

W. McKinley Bl. - N. 26th St. to N. 34th St. (SM495060056): Relaying combined sewer and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$50,000) The total estimated cost for this project including the requested amount is \$4,761,000. This project is anticipated to be completed during the 2007 construction season.

N. 10th St. - W. State St. to 300 feet m/l south of W. State St. (SM495060048): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000) The total estimated cost for this project including the requested amount is \$73,000. This project is anticipated to be completed during the 2007 construction season.

5th Aldermanic District

W. Lisbon Ave. - N. 82nd St. to N. 83rd St. (SM495060052): Sanitary lining. (Nonassessable Sewer Maintenance Relay Fund -- \$7,000) The total estimated cost for this project including the requested amount is \$32,000. This project is anticipated to be completed during the 2007 construction season.

6th Aldermanic District

N. Hubbard St. - E. Garfield Ave. to E. Lloyd St. (SW170060106): Relaying combined sewer. The total estimated cost for this project is \$900,000. This project is anticipated to be completed during the 2006/2007 construction season.

8th Aldermanic District

S. 35th St. Viaduct - W. Canal St. to the Menomonee River (Canal Phase 2 - Storm) (SM495060061): Storm Sewer Lining. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000) The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2006/2007 construction season.

10th Aldermanic District

W. Blue Mound Rd. - N. 40th St. to N. 44th St. (WT410061065): Joint seal. (Nonassessable Water Fund -- \$15,000) The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2007 construction season.

N. Story Pky. - N. Pinecrest St. to W. Blue Mound Rd. (SM495060053): Relaying sanitary sewer and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$35,000) The total estimated cost for this project including the requested amount is \$400,000. This project is anticipated to be completed during the 2007 construction season.

15th Aldermanic District

N. 21st St. - W. Lloyd St. to W. Brown St. (SM495060051): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$13,000) The total estimated cost for this project including the requested amount is \$133,000. This project is anticipated to be completed during the 2007 construction season.

N. 25th St. - W. Lloyd St. to W. Brown St. (SM495060050): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$13,000) The total estimated cost for this project including the requested amount is \$147,000. This project is anticipated to be completed during the 2007 construction season.

Various Aldermanic Districts

City wide (SM495060060): Sanitary sewer system capacity analysis. (Nonassessable Sewer Maintenance Relay Fund -- \$50,000) The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2006/2007 construction season.
