THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$968,000 for a total estimated cost of these projects being \$14,336,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$968,000 with the total cost estimated to be \$14,336,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

N. 26th St. - W. Roosevelt Dr. to W. Atkinson Ave. (SM495090006): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$59,000. This project is anticipated to be completed during the 2009 construction season.

System 1205 Department of Justice Rehabilitation Work. (SM495090100): Sanitary sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$28,000). The total estimated cost for this project including the requested amount is \$348,000. This project is anticipated to be completed during the 2009/2010 construction seasons.

System 1225 Department of Justice Rehabilitation Work (SM495090103): Sanitary sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$112,000). The total estimated cost for this project including the requested amount is \$1,400,000. This project is anticipated to be completed during the 2009/2010 construction seasons.

E. North Ave. - N. Bartlett Ave. to N. Oakland Ave. (SM495090014): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$860,000. This project is anticipated to be completed during the 2010 construction season.

4th Aldermanic District

Clybourn Street Vertical Lift Bridge over the Milwaukee River (BR100090104): Preliminary engineering for structural steel repairs and painting. (City Share Nonassessable Structure Fund -- \$150,000). The total estimated cost for this project including the requested amount is \$5,150,000. This project is anticipated to be completed during the 2009 construction season.

W. St. Paul Ave. - N. 27th St. to N. 28th St. (SM495090015): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$53,000. This project is anticipated to be completed during the 2009 construction season.

W. Concordia Ave. - N. 41st St. to N. Sherman Blvd. (SM495090013): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$106,000. This project is anticipated to be completed during the 2009 construction season.

W. Townsend St. - N. 42nd St. to N. Sherman Blvd. (SM495090010): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$44,000. This project is anticipated to be completed during the 2009 construction season.

N. 37th St. - 150 feet m/l north of W. Burleigh St. to W. Fond du Lac Ave. (SM495090007): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2009 construction season.

S. 28th St. - W. Lincoln Ave. to W. Hayes Ave. (SM495080039): Relaying combined sewer.

(Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$97,000. This project is anticipated to be completed during the 2009 construction season.

- W. Crawford Ave. S. 84th St. to S. 87th St. (WT410100004): Relaying water main. (Nonassessable Water Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$215,000. This project is anticipated to be completed during the 2010 construction season.

- S. Princeton Ave. 350 feet m/l south of W. Sunbury Ct. to S. 37th St. (SM495090008): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$142,000. This project is anticipated to be completed during the 2009 construction season.
- S. 72nd St. at W. Bennett Ave. (Sponsored by the City of West Allis) (ST211090138) Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$5,000). The total estimated cost for this project including the requested amount is \$5,000. This project is anticipated to be completed during the 2009 construction season.

System 1780 Department of Justice Rehabilitation Work. (SM495090101): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$23,000). The total estimated cost for this project including the requested amount is \$753,000. This project is anticipated to be completed during the 2009/2010 construction seasons.

- W. Lapham Blvd. S. 2nd St. to S. 4th St. (SM495090009): Relaying combined sewer. The total estimated cost for this project is \$260,000. This project is anticipated to be completed during the 2009 construction season.
- W. National Ave. S. 11th St. to S. 12th St. (SM495090011): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project is \$55,000. This project is anticipated to be completed during the 2009 construction season.
- S. 1st St. S. Kinnickinnic Ave. to E. Maple St. (WT410100009): Relaying water main. (Nonassessable Water Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2010 construction season.
- S. 2nd St. W. Lapham Blvd. to W. Mitchell St. (SM495090012): Relaying combined sewer. The total estimated cost for this project is \$113,000. This project is anticipated to be completed during the 2009 construction season.

S. 3rd St. - W. Lapham Blvd. to W. Mitchell St. (SM495080064): Relaying combined sewer. The total estimated cost for this project is \$170,000. This project is anticipated to be completed during the 2009 construction season.

Oak Creek Channel - W. College Ave. to W. Ramsey Ave. (SM493090102) File Number 081488: Cattail removal from Oak Creek Channel. The total estimated cost for this project is \$25,000. This project is anticipated to be completed during the 2009 construction season.

W. Oklahoma Ave. - S. 24th St. to S. 26th St. (ST211090139): Median revision. (Nonassessable Reconstruction Paving Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2009 construction season.
