#### Abstract

Charter ordinance file no. 971618, passed March 3, 1998 and effective May 24, 1998, permitted employes who qualify as general city employes eligible upon retirement for benefits under s. 36-05-1-h-4 and retirees who qualify as beneficiaries receiving benefits under s. 36-05-1-h-4, a one year window in which to re-select a spouse survivor option. This amendment extends the window for an additional year to May 24, 2000. The Mayor and Common Council of the City of Milwaukee do ordain as follows:


Part 1: Part 1 of charter ordinance common council file no. 971618 passed March 3, 1998 and effective May 24, 1998, is amended to read:
Members who have selected a protective survivorship option under s. 36-05-7-b-4 effective on or after January 1, 1993, naming their spouse as beneficiary, and qualify as general city employes eligible upon retirement for benefits under s. 36-05-1-h-4, and retired members who have selected a spouse survivor option effective on or after January 1,1993, naming their spouse as beneficiary, and qualify as a beneficiary under s. 36-05-1-h-4 shall be permitted a period of [[one]] >>2<< calendar [[year]] >>years<< from the effective date of this charter ordinance in which to re-select a spouse survivor option.

Part 2. This is a charter ordinance and shall take effect 60 days after its passage and publication, unless within such 60 days a referendum petition is filed as provided in s. 66.01(5), Wis. Stats., in which event this ordinance shall not take effect until submitted to a referendum and approved by a majority of the electors voting thereon.
