Resolution relative to application, acceptance and funding of the Fetal Infant Mortality Review Grant. (Health Department)

This resolution authorizes the Health Department to apply for, accept and fund the Fetal Infant Mortality Review Grant project from the U.S. Health Resources and Services Administration through the Black Health Coalition of Wisconsin in the amount of \$100,000. The purpose of the project is to resume the interdisciplinary review of infant deaths occurring in the City of Milwaukee to identify opportunities to reduce infant mortality and support families at risk.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the U.S. Health Resources and Services Administration through the Black Health Coalition of Wisconsin for the interdisciplinary review of infant deaths occurring in the city of Milwaukee to identify opportunities to reduce infant mortality and support families at risk; and

Whereas, The operation of this grant project from June 1, 2004 to May 31, 2005 would cost \$100,000 entirely provided by the grantor; now, therefore, be it
