Whereas, Program Eligibility Requirements and Design Guidelines were established by the Common Council under File No. 971697 on March 3, 1998, for facade grant activity; and

Whereas, More attractive storefronts make Milwaukee a more pedestrian friendly and attractive place for businesses, residents and visitors; and

Whereas, The City may leverage significant amounts of private investment and improvements to the facades of commercial properties if citywide grants are available to assist property owners or businesses to upgrade their storefronts and principle facades; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the City Comptroller is authorized and directed to transfer \$400,000 from the Development Fund Project Account No. UR03390000 to the Citywide Facade Grant Project Account No. UR03392002; and, be it

Further Resolved, That these funds are designated for citywide downtown and neighborhood facade grant activity under the guidelines established by the Common Council; and, be it
