Whereas, Milwaukee Water Works owns and operates facilities that were built as early as the early 1920's; and

Whereas, Some of the existing HVAC systems have been in operation well beyond their useful life; and

Whereas, There are numerous options for the replacement of this equipment and experts in this area may identify synergies between heating and cooling which could result in significant energy efficiencies; and

Whereas, It is impractical to develop precise bidding specification for the services; now, therefore, be it
