A substitute ordinance to further amend the 2019 rates of pay of offices and positions in the City Service.

This substitute ordinance changes the rates of pay in the following departments:

Department of Neighborhood Services, Police Department

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

**Part 1.** Part 1, Section 1 of ordinance File Number 180628 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 25, 2018 - December 2, 2018):

Under Pay Range 1GX, add the title "Fire Protection Engineer Supervisor (2)".

**Part 2.** Part 1, Section 2 of ordinance File Number 180628 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 26, 2018 - December 16, 2018):

Under Pay Range 2GN, add the title of "Intelligence Analyst (1)".

Part 3. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
