Whereas, The Community and Economic Development Committee recommends approval of the Funding Allocation Plan of activities and funding recommendation for funding year 2011 as attached; and

Whereas, The City of Milwaukee appears to be eligible for community development entitlement funding for year 2011 estimated at \$26,315,122 (CDBG funds \$18,200,000; HOME funds, \$6,800,000; ESG funds, \$740,186; and HOPWA funds \$574,936); now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the 2011 Funding Allocation Plan is approved as attached; and, be it
