Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$2,836,900 for a total estimated cost of \$3,184,000.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$2,836,900. The total estimated cost of these projects is \$3,184,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

# 2nd Aldermanic District

W. Florist Ave. - N. 68th St. to N. 76th St. (ST211070124) File Number 061097: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (0 -7 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$59,000; Nonassessable Reconstruction Paving Fund -- \$500,000). The total estimated cost for this project including the requested amount is \$635,000. This project is anticipated to be completed during the 2012 construction season.

# 3rd Aldermanic District

E. Back Bay - A point east of N. Terrace Ave. to N. Terrace Ave. (ST211110128) File Number 111280: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (1-7 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$3,000; Nonassessable Reconstruction Paving Fund -- \$50,000). The total estimated cost for this project including the requested amount is \$63,000. This project is anticipated to be completed during the 2012 construction season.

W. Courtland Ave. - W. Potomac Ave. to N. 84th St. (ST211110126) File Number 090907: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$3,100; Nonassessable Reconstruction Paving Fund -- \$50,000). The total estimated cost for this project including the requested amount is \$62,000. This project is anticipated to be completed during the 2012 construction season.

W. Peck Ct. - N. 86th St. to a point west of N. 86th St. (ST211060113) File Number 091621: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (13 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$2,500; Nonassessable Reconstruction Paving Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$38,000. This project is anticipated to be completed during the 2012 construction season.

W. Townsend St. - N. 84th St. to N. 86th St. (ST211060149) File Number 100011: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7 -8 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$2,000; Nonassessable Reconstruction Paving Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$122,000. This project is anticipated to be completed during the 2012 construction season.

N. 88th St. - W. Tucker Pl. to W. Capitol Dr. (Including W. Tucker Pl. - W. Lisbon Ave. to W. Elmore Ave.) (ST211120120) File Number 091621: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6-10 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$18,200; Nonassessable Reconstruction Paving Fund -- \$225,000). The total estimated cost for this project including the requested amount is \$268,000. This project is anticipated to be completed during the 2012 construction season.

- S. 36th St. W. Burnham St. to W. Mitchell St. (ST211120152) File Number 100309: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (4 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$2,000; Nonassessable Reconstruction Paving Fund -- \$135,000). The total estimated cost for this project including the requested amount is \$152,000. This project is anticipated to be completed during the 2012 construction season.

(ST211030103) File Number 091545: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (14 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$1,200; Nonassessable Reconstruction Paving Fund -- \$50,000). The total estimated cost for this project including the requested amount is \$62,000. This project is anticipated to be completed during the 2012 construction season.

Hawley Rd. to S. 70th St. (ST211110139) File Number 111369: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (2-7 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$21,000; Nonassessable Reconstruction Paving Fund -- \$760,000). The total estimated cost for this project including the requested amount is \$830,000. This project is anticipated to be completed during the 2012 construction season.

(Assessable Reconstruction Paving Fund -- \$4,000; Nonassessable Reconstruction Paving Fund -- \$170,000). The total estimated cost for this project including the requested amount is \$194,000. This project is anticipated to be completed during the 2012 construction season.

W. St. Paul Ave. - N. 91st St. to N. 92nd St. (Including N. 91st St. - W. St. Paul Ave. to W. Blue Mound Rd.) (ST211120149) File Number 100309: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$2,000; Nonassessable Reconstruction Paving Fund -- \$55,000). The total estimated cost for this project including the requested amount is \$69,000. This project is anticipated to be completed during the 2012 construction season.

Fremont Pl. - S. 63rd St. to S. 67th St. (ST211120151) File Number 111280: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7-8 foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$4,000; Nonassessable Reconstruction Paving Fund -- \$90,000). The total estimated cost for this project including the requested amount is \$114,000. This project is anticipated to be completed during the 2012 construction season.

(Assessable Reconstruction Paving Fund -- \$3,000; Nonassessable Reconstruction Paving Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2012 construction season.

W. Wedgewood Dr. - S. Honey Creek Dr. to S. 76th St. (Including W. Wedgewood Ct.) (ST211120136) File Number 110831: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6 foot width of tree border area), and grading.
