This substitute resolution authorizes the Health Department accept and fund the Bioterrorism Grant - Focus CRI (Cities Readiness Initiative) project from the Centers for Disease Control through the State of Wisconsin Division of Health Services in the amount of \$173,732 to aid cities in increasing their capacity to deliver medicines and medical supplies during a large-scale public health emergency.

Resolved, By the Common Council of the City of Milwaukee, that acceptance of the grant from the Centers for Disease Control through the State of Wisconsin Division of Health Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant parent account of the 2018 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled Bioterrorism Grant Focus CRI:

3. Expend from the 2018 grant budget funds for equipment as specified in the grant budget;
4. Enter into leases and contracts as indicated in the grant budget; and, be it
