THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$218,000 for a total estimated cost of these projects being \$2,015,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined

assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$218,000 with the total cost estimated to be \$2,015,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

2nd Aldermanic District

N. 70th St. - W. Capitol Dr. to W. Congress St. (ST211140131): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$320,000. This project is anticipated to be completed during the 2014 construction season.

N. 72nd St. - W. Congress St. to W. Hampton Ave. (ST211140132): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$25,000). The total estimated cost for this project including the requested amount is \$355,000. This project is anticipated to be completed during the 2014 construction season.

3rd Aldermanic District

N. Weil St. - E. Meinecke Ave. to E. Center St. (ST211140133): Removing and replacing all curb and gutter. Removing and replacing concrete sidewalk and driveway approaches where necessary. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$175,000. This project is anticipated to be completed during the 2014 construction season.

5th Aldermanic District

Alley between W. Hadley St., W. Locust St., N. 81st St., and N. 82nd St. (ST212140124): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2014 construction season.

6th Aldermanic District

Alley between W. McKinley Pl., W. Vliet St., N. 7th St., and N. 8th St. (northerly east-west leg) (ST212140116): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2014 construction season.

7th Aldermanic District

Alley between W. Melvina St., W. Vienna Ave., N. 51st Blvd., and N. 52nd St. (ST212140119):

Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2014 construction season.

11th Aldermanic District

- S. 45th St. at W. Crawford Ave. (Sponsored by the City of Greenfield) (ST211120190): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$16,000). The total estimated cost for this project including the requested amount is \$40,000. This project is anticipated to be completed during the 2012 construction season.
- S. 79th St. W. Morgan Ave. to W. Ohio Ave. (ST211140130): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2014 construction season.

12th Aldermanic District

Alley between W. Becher St., W. Grant St., S. 17th St., and S. 18th St. (ST212140121): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2014 construction season.

Alley between W. Burnham St., W. Rogers St., W. Windlake Ave., and S. 8th St. (omit southwest portion of northeast-southwest leg) (ST212140115): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2014 construction season.

14th Aldermanic District

S. Nevada St. - E. Oklahoma Ave. to W. Manitoba St. (ST211140128): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2014 construction season.

15th Aldermanic District

N. 32nd St. - W. Lisbon Ave. to W. North Ave. (ST211140129): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund -- \$40,000) The total estimated cost for this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2014 construction season.

Alley between W. Center St., N. Grant Blvd., W. Hadley St., and N. Sherman Blvd. (ST212140120):

Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2014 construction season.

Alley between W. Cherry St., W. Galena St., N. 28th St., and N. 29th St. (ST212110101): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2014 construction season.

Alley between W. Garfield Ave., W. North Ave., N. 44th St., and N. 45th St. (ST212140117): Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2014 construction season.

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
