Substitute ordinance to further amend the 2002 offices and positions in the City Service under control of the Common Council.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 1 of ordinance File Number 010468 relative to offices and positions in the City Service is hereby amended as follows:

Under "Health Department, Home Environmental Health Division, Childhood Lead Poisoning Prevention Program (W)", delete one position of "Lead Project Inspection Supervisor (W)", and add one position of "Environmental Health Field Supervisor (W)"; under "Lead Pilot Project Grant (E)", delete one position of "Lead Project Coordinator (HUD) (X) (E), and add one position of "Lead Hazard Prevention Manager (X) (E)."

Part 2. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
