Resolution relative to application, acceptance and funding of a State of Wisconsin Waterways Commission Grant. (DPW)
- ANALYSIS - This resolution authorizes the Department of Public Works to apply for, accept and fund a River Skimmer Grant project from the State of Wisconsin in the amount of \$200,000 with a city share of \$100,000 and a grantor share of up to \$100,000. The purpose of the project is to fund the purchase of a river skimmer.

Whereas, the Common Council has previously adopted file no. 970841 authorizing the Commissioner of Public Works to apply for a State of Wisconsin Waterways grant to fund the acquisition of a river skimmer; and

Whereas, The purchase of this river skimmer would cost \$200,000 of which \$100,000 (50%) would be provided by the city and up to \$100,000 (50%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the State of Wisconsin is authorized and the Department of Public Works shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Encumber in the parent accounts of the 1998 Special Revenue Accounts-Grant and Aid Projects, the following amounts for the project/program titled

2. Create a Special Revenue Fund - Grant and Aid Projects and the necessary expenditure and revenue accounts; appropriate to these accounts the amount required under the grant agreement and transfer the corresponding offsetting estimated revenue;

3. Establish the necessary grant performance submeasures; and, be it

Further Resolved, That these funds are appropriated to Department of Public Works which is authorized to:

1. Expend from the amount appropriated sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;

2. Expend from the 1998 grant budget funds for specific items of equipment;
3. Enter into subcontracts and leases as detailed in the grant budget.
