Whereas, Participation on the committee will require the expenditure of funds for travel, lodging and related expenses; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Common Council authorizes the participation of Ald. Joe Davis, Sr. as Chair of the National League of Cities' Community and Economic Development Policy and Advocacy Committee; and, be it

Further Resolved, That the City Clerk is authorized to expend funds from the Economic Development Committee Fund Special Purpose Account (Account Number 0001-1310-S123-006300) for travel, lodging and per diem expenses related to Ald.
