Arthur Av., W. Harrison Av., S. 65th St., S. 66th St. with a total estimated cost of \$185,000, of which the City's share is \$175,000 and the City of West Allis' share is \$17,000.

Whereas, The alley was constructed in 1954 and is in need of rehabilitation; and

Whereas, The project is included in the Department of Public Works Alley reconstruction Program;

and

Whereas, The City of Milwaukee and City of West Allis share jurisdiction ownership of the east west leg and will share the construction costs; and

Whereas, The City of Milwaukee will be the lead agency of the project design and construction; and

Whereas, This project is programmed for construction in 2020; and

Whereas, Funding for the construction phase of the project was included in resolution 191784; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public works is hereby authorized to execute the project agreement titled "Cost Sharing Memo of Understanding Between the City of Milwaukee and the City of West Allis" for the cost sharing of the reconstruction of the Alley between W. Arthur Av., W. Harrison Av., S. 65th St., S. 66th St .copies of which are attached to Common Council Resolution File Number 200127, and are incorporated by reference as though set forth in full.
