THE CHAIR

Substitute resolution relative to acceptance and funding of the 2023-2024 Communicable Disease Prevention Grant from the Wisconsin Department of Health Services, Division of Public Health.

Substitute resolution authorizes the Health Department to accept, and fund the 2023-24 Communicable Disease Prevention grant from the Wisconsin Department of Health Services in the amount of \$28,000 with a City share of \$0 and a grantor share of \$28,000. The funding will provide equipment, training, supplies, and public information to assure the response and competencies around communicable disease issues.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to assure response and competencies in communicable disease prevention for local health departments; and

Whereas, The operation of this grant program from July 1, 2023 to June 30, 2024 will cost \$28,000, comprised of \$28,000, or 100%, grantor share and \$0, or 0%, City share; now, therefore, be it;

Further Resolved, that the Commissioner of Health or their designee is authorized to execute the grant agreement for these funds; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant parent account of the 2023 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled Communicable Disease Prevention:

2. Create the necessary Special Revenue Fund Grant and Aid Project/Grant and Project Levels; budget to these Project/Grant values the amounts required under the grant agreement; and be it
