THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,046,000 for a total estimated cost of these projects being \$13,240,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,046,000 with the total cost estimated to be \$13,240,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

W. Douglas Ave. - W. Kaul Ave. to N. Sherman Blvd. (WT410180634): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2018 construction season.

N. Teutonia Ave. - 100 feet south of W. Carmen Ave. to W. Bobolink Ave. (WT410180631): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund

Budget Line 6410 -- \$22,000). The total estimated cost for this project including the requested amount is \$315,000. This project is anticipated to be completed during the 2018 construction season.

N. 52nd St. - W. Custer Ave. to W. Silver Spring Dr. (WT410180623): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$22,000). The total estimated cost for this project including the requested amount is \$325,000. This project is anticipated to be completed during the 2018 construction season.

#### 2nd Aldermanic District

W. Beckett Ave. - N. 73rd St. to W. Fiebrantz Ave. (WT410180003): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2018 construction season.

W. Fiebrantz Ave. - N. 72nd St. to W. Beckett Ave. (WT410180004): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$155,000. This project is anticipated to be completed during the 2018 construction season.

W. Perkins Pl. - W. Beckett Ave. to W. Appleton Ave. (WT410180005): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2018 construction season.

N. 57th St. - W. Villard Ave. to W. Sheridan Ave. (WT410180624): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$4,000; Nonassessable Water Fund Budget Line 6410 -- \$31,000). The total estimated cost for this project including the requested amount is \$515,000. This project is anticipated to be completed during the 2018 construction season.

N. 73rd St. - W. Capitol Dr. to W. Congress St. (WT410180002): Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$4,000; Nonassessable Water Fund Budget Line 6410 -- \$36,000). The total estimated cost for this project including the requested amount is \$645,000. This project is anticipated to be completed during the 2018 construction season.

This project is anticipated to be completed during the 2017 construction season.

Joint repair of various streets by contract (ST211170187): (Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2017 construction season.

2017 Sanitary Manhole Rehabilitation (SM494170001): (Infiltration/Inflow Reduction Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$900,00. This project is anticipated to be completed during the 2017 construction season.
