Substitute resolution relative to legislative bills.

Whereas, The Judiciary and Legislation Committee of the Common Council has recommended the following positions on the bills hereinafter listed and the Common Council being advised of said matters; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that it hereby approves the following legislative

bills and instructs the Division of Intergovernmental Relations to appear before the proper committees to support such bills and use its best endeavors to have the same enacted into law, viz:

--- Jobs for Main Street Act of 2010, with the caveat that there be as much local control as possible in appropriating the funds.

--- AB-661 County and municipal expenditures for emergency services; and, be it

Further Resolved, That the Division of Intergovernmental Relations is to watch and report back to the Judiciary and Legislation Committee on SB-458 /AB 656 (the local regulation of ticket selling and providing a penalty).
