THE CHAIR

Resolution appropriating \$600,000 from the 2003 Common Council Contingent Fund for payment of Worker's Compensation claims.

This resolution appropriates \$600,000 from the 2003 Common Council Contingent Fund to the Department of Employee Relations' Worker's Compensation Special Purpose Account for payment of worker's compensation claims for the remainder of 2003.

Whereas, The Department of Employee Relations' Worker's Compensation Special Purpose Account is budgeted at \$7,000,000 for 2003; and

Whereas, Through December 17, 2003, \$7,266,341 has been paid in worker's compensation claims, leaving the account with a \$266,341 negative balance with at least 3 more weekly payments to be made through December 30, of 2003; and

Whereas, additional funds are needed immediately to pay worker's compensation claims during the remainder of 2003; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that an amount not to exceed \$600,000 shall be transferred

from the 2003 Common Council Contingent Fund (0001-9990-0001-C001-006300-2003) to the Department of Employee Relations' Worker's Compensation Special Purpose Account (612001-0001-1654-1614-S176-2003); and, be it

Further Resolved, That the City Comptroller is authorized and directed to establish all funds and necessary accounting procedures to fulfil the intent of this resolution.
