## THE CHAIR

Substitute resolution to ratify and confirm the final agreement between the City of Milwaukee and the Fire Equipment Dispatchers, Local #494, International Brotherhood of Electrical Workers, AFL-CIO. The purpose of this resolution is to confer common council approval, ratification and confirmation on the memorandum of understanding between the City of Milwaukee negotiating team and Fire Equipment Dispatchers, Local #494, International Brotherhood of Electrical Workers, AFL-CIO covering base wages for the time period commencing January 1, 2013, through December 31, 2013. Whereas, The total agreement between the city negotiating team and Fire Equipment Dispatchers, Local #494, International Brotherhood of Electrical Workers, AFL-CIO for the time period commencing January 1, 2013, through December 31, 2013 has been reduced to writing; and

Whereas, The memorandum of understanding embodying the agreement reached by the parties to such negotiations, copies of which are attached to Common Council File No. 121620 and incorporated herein as though fully set forth at length, was executed subject to ratification by the Common Council; now, therefore, be it

Resolved, By the common council of the City of Milwaukee, that the agreement between the city negotiating team and Fire Equipment Dispatchers, Local #494, International Brotherhood of Electrical Workers, AFL-CIO be approved; and be it

Further Resolved, That the city negotiating team is hereby authorized and directed to reduce the agreement to a formal contract between the union and the city; and be it

Further Resolved, That the proper city officials are hereby authorized and directed to execute the formal contract between the City of Milwaukee and Fire Equipment Dispatchers, Local #494, International Brotherhood of Electrical Workers, AFL-CIO which reflects the terms of the agreement; and be it

Further Resolved, That the proper city officials are hereby authorized and directed to take the necessary action or to make the necessary recommendations to the common council or the appropriate committees or boards to implement the terms of this agreement; and be it

Further Resolved, That such sums as are necessary for the implementation of the aforementioned labor contract in accordance with its terms and conditions be obtained for and charged to the appropriate departmental budget accounts in accordance with the customary reporting and accounting requirements.
