Whereas, To facilitate closing of Year 2002 financial books, transfers from 2002 Common Council Contingent Fund are necessary; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that no greater than the sum of \$60,000 in the Common Council Contingent Fund (#0001-9990-C001-006300) (2002) be transferred to the City Attorney Office's Operating Expenditures account (#0001-1490-R999-006300) (2002); and be it

Further Resolved, By the Common Council of the City of Milwaukee, that no greater than the sum of \$205,000 in the Common Council Contingent Fund (#0001-9990-C001-006300) (2002) be transferred to the Police Department's Operating Expenditures account (#0001-3310-R999-006300) (2002).
