Resolved, By the Common Council of the City of Milwaukee, that \$650,000 be and hereby is appropriated from the 2004 Reimbursable Services Advance Fund to the Department of Administration reimbursable account to provide funding for the Business Operations Division and the Information Technology and Management Division; and, be it

Further Resolved, That \$50,000 be and hereby is appropriated from the 2004 Reimbursable Services Advance Fund to the Health Department to provide funding for performing larvacide applications; and, be it

Further Resolved, That the procedures for handling and advancing funds in anticipation of reimbursable revenue be in accordance with those set forth in Common Council File 80-1513.
