THE CHAIR

A substitute ordinance relating to traffic controls.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-15 of the Code relating to Yield signs is amended by adding the following:

On West Eggert Place at North 81st Street

Part 2. Section 101-16-1 of the Code relating to Stop signs is amended by striking the following:

“On East Hadley Street at North Weil Street”

“On West Lapham Street at South 23rd Street”

Part 3. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On West Vienna Avenue at North 58th Boulevard

On West Chambers Street and North 77th Street in all directions

On East Hadley Street and North Weil Street in all directions

On West Kathryn Avenue and West Gertrude Drive in all directions

On West Lapham Street and South 23rd Street in all directions

Part 4. Section 101-18-1 of the Code relating to No Heavy Traffic is amended by adding the following:

On South 24th Street between West Morgan Avenue and West Howard Avenue

Part 5. Section 101-12-2 of the Code relating to U-turns Prohibited is amended by adding the following:

On West Lloyd Street at North Sherman Boulevard in the westbound direction
