Resolution authorizing a sidewalk replacement project in the Fifth and Fifteenth Aldermanic Districts. To provide the necessary authority for sidewalk repairs in the Fifth and Fifteenth Aldermanic Districts. Whereas, It is necessary and in the public interest to replace those sidewalk stones which are cracked, broken, out of grade or otherwise a hazard to pedestrians; and

Whereas, It is proposed that sidewalk replacement work be done in the following locations at the indicated cost:

Area bounded by West Silver Spring Drive, North 91st Street, West Hampton Avenue, and North 124th Street, in the Fifth Aldermanic District, ST230040122.

Whereas, Funds have been encumbered and thus set aside for the proposed public improvement; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works be, and is hereby authorized and directed to proceed to do the above described sidewalk replacement work and the City Comptroller is hereby authorized and directed to transfer \$87,619 from Account No. 0333-4926-ST230040000 and \$292,685 from Account No.

0330-4926 ST230040000, which is available for Subaccounts; and, be it

Further Resolved, That the proper City departments take such action as is required of them to assess the abutting properties, and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances.
