This ordinance, to be effective July 1, 2001, increases forfeitures for nonmoving traffic violations by \$2 per forfeiture.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-34-2-a to j and 7-a to j of the code is amended to read:

101-34. Stipulation Procedures, Nonmoving Traffic Violations.

2. FORFEITURE SCHEDULE.

- a. Citations issued for violation of s.101-27 except 101-27-1-a and 4: ~~[[\$13]]~~ >> \$15 <<.
- b. Citations issued for violation of ss.101-23-4 and 6, 101-27-7-d, 101-30 and 101-33: ~~[[\$18]]~~ >> \$20 <<.
- c. Citations issued for parking in prohibited zones, whether required to be posted or not, excluding violation of s.101-27: ~~[[\$28]]~~ >> \$30 <<.
- d. Citations issued for violation of ss.101-26.5 and 101-27-4: ~~[[\$28]]~~ >> \$30 <<.
- e. Citations issued for violation of ss.101-23-10, 101-26 and 101-27 during a snow emergency declared under s.101-26: ~~[[\$33]]~~ >> \$35 <<.
- f. Citations issued for violation of ss.101-24, 101-24.1, 101-24.2 and 101-25: ~~[[\$48]]~~ >> \$50 <<.

- g. Citations issued for violation of s.101-23.5: ~~[[\\$38]]~~ >>\$40<<.
- h. Citations issued for violation of s.101-27-1-a: ~~[[\\$28]]~~ >>\$30<<.
- i. Citations issued for violations of s.346.505, Wis. Stats., adopted by s.101-3: ~~[[\\$58]]~~ >>\$60<<.

7. PENALTY

- b. Violations of ss. 101-23-4 and 6, 101-27-7-d, 101-30 and 101-33:~~[[\\$18]]~~ >>\$20<< to ~~[[\\$48]]~~ >>\$50<<.
- c. Parking in prohibited zones, whether required to be posted or not, excluding s.101-27 of this code and s.346.505, Wis. Stats., adopted by s.101-3: ~~[[\\$28]]~~ >>\$30<< to ~~[[\\$48]]~~ >>\$50<<.
- d. Violations of ss. 101-26.5 and 101-27-4: ~~[[\\$28]]~~ >>\$30<< to ~~[[\\$48]]~~ >>\$50<<.
- e. Violations of ss.101-23-10, 101-26 and 101-27 during a snow emergency declared under s.101-26: ~~[[\\$33]]~~ >>\$35<< to ~~[[\\$53]]~~ >>\$55<<.
- f. Violations of ss.101-24, 101-24.1, 101-24.2 and 101-25: ~~[[\\$48]]~~ >>\$50<< to ~~[[\\$68]]~~ >>\$70<<.
- g. Violations of s.346.505, Wis. Stats., adopted by s.101-3: ~~[[\\$58]]~~ >>\$60<< to ~~[[\\$303]]~~ >>\$305<<.
- h. Violations of s.101-23.5: ~~[[\\$38]]~~ >>\$40<< to ~~[[\\$58]]~~ >>\$60<<.
- i. Violations of s.101-27-1-a.: ~~[[\\$28]]~~ >>\$30<< to ~~[[\\$48]]~~ >>\$50<<.
- j. Violations of s. 101-18: ~~[[\\$53]]~~ >>\$55<< to ~~[[\\$73]]~~ >>\$75<<.
