The City cost of the projects approved by this resolution is estimated to be \$675,000. The total estimated cost of these projects is \$730,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

3rd Aldermanic District

E. Hartford Ave. - N. Shepard Ave. to N. Marietta Ave. (WT410110642) File Number 091623:

Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$60,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2014 construction season.

N. Shepard Ave. - E. Hartford Ave. to E. Newport Ave. (WT410110643) File Number 091623: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$6,000; Nonassessable Water Fund Budget Line 6410 -- \$134,000). The total estimated cost for this project including the requested amount is \$155,000. This project is anticipated to be completed during the 2014 construction season.

6th Aldermanic District

N. 10th St. - W. Nash St. to W. Capitol Dr. (WT410140689) File Number 130868: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$22,000; Nonassessable Water Fund Budget Line 6410 -- \$453,000). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2014 construction season.
