The City cost of the projects approved by this resolution is estimated to be \$1,409,000. The total estimated cost of these projects is \$1,615,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

Cameron Avenue (3100W) over the Lincoln Creek (BR100210105) File Number 191555: Rehabilitation of fixed bridge and approaches (City Share Non-assessable Structure Fund - \$1,400,000). The total estimated cost for this project is \$1,600,000. This project is anticipated to be

completed during the 2021 construction season.

Work by MWW Prior to Paving (WT410210730) File Number 201139 Water main alteration. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 - - \$3,000). The total estimated cost of this project including the requested amount is \$5,000. This project is anticipated to be completed during the 2021 construction season.
