A substitute ordinance to further amend the 2014 offices and positions in the City Service.

This substitute ordinance changes positions in the following departments:
Health Department

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 1 of ordinance File Number 130420 relative to offices and positions in the City Service is hereby amended as follows:

Under “Health Department”, amend footnote “(A)” to read as follows:

“To expire 06/30/15 unless the CDC Public Health Preparedness Grant is extended.”;

Amend footnote “(P)” to read as follows:

“To expire 06-30-15 unless the Bioterrorism Focus CRI Grant is extended.”;

Amend footnote “(DDD)” to read as follows:

“To expire 06-30-15 unless the Seek, Test, Treat (STT): Addressing HIV in the Criminal Justice System Grant, available from Tulane University is extended.”;

And amend footnote “(O)” to read as follows:

“To expire 06/30/15 unless the Congenital Disorders Grant is extended. Also partially funds one position of Public Health Nurse.”.

Under “Consumer Environmental Health”, delete one position of “Consumer Environmental Health Division Director”, add one position of “Consumer Environmental Health Division Director (S)”, and amend footnote “(S)” to read as follows:

“To expire 06/30/15 unless the FDA Standards Grant is extended.”

Under “Family and Community Health Services Division, Milwaukee Breast Cancer Awareness Program”, delete one position of “Office Assistant IV”, add one position of “Office Assistant IV (GG) (JJ)”, and amend footnote “(JJ)” as follows:

“To expire 6/30/15 unless the Wisconsin Well Woman Program Grant, available from the State of Wisconsin - Department of Health Services, is extended.”

Part 2. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

The provisions of all other parts of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 3. This ordinance will take effect and be in force from and after its passage and publication.
