An ordinance relating to the amendment of the Official Map of the City of Milwaukee.
113-32.0121

The adoption of this ordinance will update the Official Map of the City of Milwaukee.
Whereas, The Mayor and Common Council of the City of Milwaukee do ordain as follows:

There is hereby added to the City of Milwaukee Code a new section to read as follows:

Section 113-32.0121 the Official Map, as mentioned and provided for in Section 113-32, is hereby amended so as to include the following additions as shown in the report on file in the City Clerk's office.

1. Alley in the block bounded by West Birch Avenue, West Sheridan Avenue, North 60th Street and North 62nd Street. The opening of a 28-foot wide north-south alley, right-of-way.

1. North 8th Street from West Michigan Street south to its terminus. The vacation of a variable width street right-of-way.
2. North 8th Street (west side) from West Michigan Street south to a point. The sale of a triangular portion of excess State right-of-way.
3. North 9th Street from West Michigan Street south to its terminus. The vacation of a 60-foot wide street right-of-way.
4. West McAuley Place between North 8th Street and North 9th Street. The sale of excess State right-of way that is no longer necessary.
5. West McAuley Place between North 8th Street and North 9th Street. Repealing the ordinance naming West McAuley Place to the roadway that is no longer necessary.
