Substitute resolution relating to the acceptance of funds for City of Milwaukee Youth Council activities.

This resolution authorizes the City Clerk to accept up to \$50,000 in contributions on behalf of the City of Milwaukee Youth Council and expend these contributions for purposes related to the organization, education and training of the Council.

Whereas, Since its creation on July 7, 2004, the City of Milwaukee Youth Council has been carrying out its mission to represent the interest and opinions of young people throughout the City; and

Whereas, Various individuals and organizations have offered to contribute funds to assist in the organization and training of the City of Milwaukee Youth Council; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that pursuant to s. 304-24 of the

Milwaukee Code, the City Clerk is authorized to accept cash donations on behalf of the City of Milwaukee Youth Council; and, be it

Further Resolved, That these funds shall be expended at the direction and in the sole discretion of the City Clerk for purposes related to the organization, education and training of the City of Milwaukee Youth Council; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer appropriations and estimated revenue from the 2006 Special Purpose Account for Contributions, 0001-2110-0001-006300 and the Estimated Revenue Account for Contributions, 0001-9990-0001-09850 to the City Clerk Office's special account, 0001-1310001-DXXX-006300, and estimated revenue account, 0001-1310-0001-009850, to be established by the City Comptroller, up to the amount of \$50,000; and, be it

Further Resolved, That the City Comptroller is authorized and directed to establish the necessary accounts and accounting procedures to fulfill the intent of this resolution.
