The Chair

Resolution relative to the application, acceptance and funding for the 2005 Consolidated Contract. (Health Department)

This resolution authorizes the Health Department to apply for, accept and fund the 2005 Consolidated Contract from the Wisconsin Department of Health and Family Services in the amount of \$2,070,815 with a city share of \$412,235 and a grantor share of \$1,658,580. The purpose of the contract is to continue programming in six service areas during 2005 under the Consolidated Contract allocations.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health and Family Services for the 2005 Consolidated Contract; and

Whereas, The operation of this grant project from 01/01/05 to 12/31/05 would cost \$2,070,815 of which \$412,235 (20%) would be provided by the city and \$1,658,580 (80%) would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Department of Health and Family Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 030712 (Grant Ordinance); and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2005 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled 2005 Consolidated Contract:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant Levels; budget against these Project/Grant values the amount required under the grant agreement;

3. Establish the necessary City Share Project Values; and, be it

Further Resolved, That these funds are budgeted to the Health Department which is authorized to:

1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
2. Expend from the 2005 grant budget funds for specific items of equipment;
3. Expend from the 2005 grant budget funds for training and out-of-town travel by departmental staff;
4. Enter into subcontracts as detailed in the grant budget; and, be it
