Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$3,167,500 for a total estimated cost of these projects being \$3,715,500.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$3,167,500. The total estimated cost of these projects is \$3,715,500.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

4th Aldermanic District

W. Juneau Ave. - N. 27th St. to N. 28th St. (SM495150060) File Number 150997: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$268,000). The total estimated cost for this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2016 construction season.

4th and 15th Aldermanic Districts

N. 27th St. and W. Vliet St., N. 27th St. and W. Cherry St. (Intersections) (SM495150059) File Number 150997: Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$98,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2016 construction season.

W. Chambers St. - N. 26th St. to N. 27th St. (SM495150042) File Number 150032: Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$48,000). Seal coating of various streets by contract (ST211150186) File Number 141515: (Nonassessable Reconstruction Paving Fund -- \$20,000, Additional Funds). The total estimated cost for this project including the requested amount is \$460,000. This project is anticipated to be completed during the 2015 construction season.
