Substitute resolution authorizing the return of real estate located at $2204-06\ N.\ 6^{th}$ St., in the 6th Aldermanic District of the City of Milwaukee to its former owner upon payment of all city and county tax liens and any special improvement bonds, with all interest and penalty thereon and all costs as sustained by the City in foreclosing and managing said real estate. (Glorious Malone)

Permits return of property owned by the City under conditions imposed by Ordinance File Number 901739, passed by the Common Council on July 28, 1992.

Whereas, The property located 2204-06 N. 6th Street, tax key number 352-0102-8 previously owned by Glorious Malone, has delinquent taxes for 1998 and 1999 and was foreclosed upon pursuant to Sec. 75.521, Wis. Stats., and a fee simple absolute was obtained in favor of the City of Milwaukee dated May 7, 2001; and

Whereas, Glorious Malone, would like to reclaim said property by paying all City and County real estate taxes, plus accrued interest and penalties to date of payment, and all costs as sustained by the City in the foreclosing and management of said property since May 7, 2001; and

Whereas, The Department of Neighborhood Services indicates currently no unabated orders exist on this property but there is outstanding orders on the properties at 1718 West Center Street and 2776 North 6^{th} Street; and

Whereas, The City Treasurer's records show outstanding 1998 and 1999 taxes, plus interest, penalties and costs; and

Whereas, The Department of City Development reports that this property is located in the new African-American Cultural and Entertainment District. Said property is occupied but no rent has been collected and administrative costs have been incurred totalling \$450. Various costs in the amount of \$217.99 were also incurred by the Department for miscellaneous repairs; and

Whereas, The Health Department reported no outstanding orders or notices, and no clean up notices have been issued against this property under Section 80-8 or 17-12 in 2000 or thus far in 2001; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that in order to return the property at 2204-06 N. 6th St., a cashier's check must be submitted in the amount indicated by the City Treasurer within forty-five (45) calendar days of the adoption of this resolution; and, be it

Further Resolved, That the City Attorney is then authorized to enter into a stipulation with the former owner to reopen and vacate the City's judgment in Milwaukee County Circuit Court Case No. 00-CV-010598 known as the 2000-4, In Rem Parcel 250, securing the court's order and recording said order with the Milwaukee County Register of Deeds; and, be it

Further Resolved, That if the above delinquent taxes, interest, and penalties are not paid within forty-five (45) calendar days of the adoption of this resolution, this process becomes null and void. CC CC kmm 7-18-2001
