Substitute resolution relative to application, acceptance and funding of the National Training and Technical Assistance on Homicide Review Grant from the U.S. Department of Justice - Community Oriented Policing Services (COPS).

This resolution authorizes the Health Department to apply for, accept and fund the National Training and Technical Assistance on Homicide Review Grant from the U.S. Department of Justice - Community Oriented Policing Services (COPS) in the amount of \$456,059 provided by the grantor. The purpose of the grant is to provide training and technical assistance to local police departments and other criminal justice professionals in urban districts to build their capacity to prevent homicides and related events (e.g., nonfatal shootings and near fatal domestic violence incidents) using a "homicide review" prevention model.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the National Training and Technical Assistance on Homicide Review Grant from the U.S. Department of Justice - Community Oriented Policing Services (COPS); and

as, The operation of this grant project from 10/1/10 to 9/30/12 would cost \$456,059 provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the U.S. Department of Justice - Community Oriented Policing Services (COPS) is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2010 Special Revenue Grant and Aid Projects Funds, the following amount for the project titled National Training and Technical Assistance on Homicide Review Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project Grant Levels; budget against these Project/Grant values the amounts required under the grant agreement; and, be it

Further Resolved, That these funds are budgeted to the Health Department which is authorized to:

- 1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
- 2. Expend from the 2010 grant budget funds for training and out-of-town travel by departmental staff;
- 3. Enter into leases and subcontracts as detailed in the grant budget; and
- 4. Expend from the 2010 grant funds for equipment as deemed necessary for program operation.
