A substitute ordinance to further amend the 2014 offices and positions in the City Service.

This substitute ordinance changes positions in the following departments:

Health Department, Department of Neighborhood Services, Department of Public Works

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

**Part 1.** Section 1 of ordinance File Number 130420 relative to offices and positions in the City Service is hereby amended as follows:

Under “Health Department”, amend footnote “(T)” to read as follows:

“To expire 07/31/15 unless the SURVNET ACA Grant available from the Wisconsin Department of Health Services is extended.”

And amend footnote “(AAA)” to read as follows:

“To expire 07/31/15 unless the HIV Risk Reduction Grant from the University of Wisconsin-Milwaukee is extended. A portion of the Nurse Practitioner position may be funded by the Dual Protection Grant.”

Under “Disease Control and Environmental Health Services Division, HIV Women’s Project (L)” delete one position of “Public Health Nurse (X)(G)(L)(AAA)”, add one position of “Public Health Nurse (X)(G)(L)”, and amend footnote “(L)” to read as follows:

“To expire 07-31-15 unless the HIV Women’s Project Grant, available from the Medical College of Wisconsin, is extended.”

Under “Office of Violence Prevention”, delete one position of “Violence Prevention Data Manager (X)(H)”, add one position of “Violence Prevention Research Coordinator (X)(H)(OO)”, and add footnote “(OO)” to read:

“To expire 8/31/15 unless the Homicide Review Training and Technical Assistance Grant from the U.S. Department of Justice - Community Oriented Policing Services (COPS) is extended.”

**Part 2.** Section 1 of ordinance File Number 130420 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2014 - December 22, 2013):

Under “Department of Public Works - Infrastructure Services Division, Field Operations - Electrical Services

Decision Unit, Facilities Development and Management Section, Construction and Repairs”, delete the positions of “Electrical Maintenance Program Manager”, “Infrastructure Repair Crew Leader”, “Infrastructure Repair Worker”, and “Bricklayer”. Add one position of “Sewer Operations Supervisor”, one position of “Sewer Mason”, and two positions of “Special Laborer (Electrical Services)”.

**Part 3.** Section 1 of ordinance File Number 130420 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 14, 2014 - June 22, 2014):

Under “Health Department, Communications & Public Relations”, delete one position and title of “Violence Prevention Data Manager (X)(H)”.

Under “Office of Violence Prevention”, add one position of “Violence Prevention Research Coordinator (X)(H)(OO)”.

Under “Department of Neighborhood Services, Administration Services Section”, delete one position of “Administrative Specialist (X) and add one position of “Administrative Services Supervisor (X)”.

**Part 4.** All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

**Part 5.** The provisions of Part 2 of this ordinance are deemed to be in force and effect from and after Pay Period 1, 2014 (December 22, 2013).

**Part 6.** The provisions of Part 3 of this ordinance are deemed to be in force and effect from and after Pay Period 14, 2014 (June 22, 2014).

The provisions of all other parts of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

**Part 7.** This ordinance will take effect and be in force from and after its passage and publication.
