This resolution authorizes the payment from the Remission of Taxes Fund in the amount of \$5,901.68 for special assessments placed on the tax roll between 1980 and 1986 for six properties owned by the State of Wisconsin and Milwaukee County, which accounts are beyond the 13-year statute of limitations pursuant to sec. 75.20, Stats.
