## THE CHAIR

Substitute resolution relative to acceptance and funding of the 2024-2025 Wisconsin Well Woman Program grant from the Wisconsin Department of Health Services.

Substitute resolution authorizes the Health Department to accept, and fund the 2024-2025 Wisconsin Well Woman Program grant from the Wisconsin Department of Health Services in the amount of \$490,000 with a City share of \$0 and a grantor share of \$490,000. The funding will provide access to screenings, health education, and outreach to at-risk and underserved women ages 35-64.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to provide access to screenings, health education, and outreach to atrisk and underserved women ages 35-64; and

Whereas, The operation of this grant program from July 1, 2024 to June 30, 2025 will cost \$490,000 comprised of \$490,000, or 100%, grantor share and \$0, or 0%, City share; now, therefore, be it;

Resolved, By the Common Council of the City of Milwaukee, that the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, that the Commissioner of Health or their designee is authorized to execute the grant agreement for these funds; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant parent account of the 2024 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled 2024-2025 Wisconsin Well Woman Grant:
