Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District

N. 47th St. - W. Hampton Ave. to W. Fairmount Ave. (ST21100116) File Number 020390: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$55,600; Nonassessable Reconstruction Paving Fund -- \$79,700)

Alley between W. Melvina St., W. Vienna Ave., N. 19th St., and N. 19th Pl. (ST212030104) File Number 021027: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where needed. (Assessable Alley Paving Fund -- \$49,700; Nonassessable Alley Paving Fund -- \$41,800)

2nd Aldermanic District

Alley between W. Capitol Dr., W. Melvina St., N. 56th St., and N. 58th St. (ST212030122) File Number 020020: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where needed. (Assessable Alley Paving Fund -- \$58,700; Nonassessable Alley Paving Fund -- \$15,000)

N. Terrace Ave. - A point south of E. LaFayette Pl. to E. North Ave. (ST211020149) File Number 020390: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and grading. (Assessable Reconstruction Paving Fund -- \$124,800; Nonassessable Reconstruction Paving Fund -- \$140,400)

Montana St., S. 45th St., and S. 46th St. (ST212030101) File Number 901468: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where needed. (Assessable Alley Paving Fund -- \$66,000; Nonassessable Alley Paving Fund -- \$20,000)

Alley between W. Euclid Ave., W. Ohio Ave., S. 22nd St., and S. 23rd St. (ST212030125) File Number 020286: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where needed. (Assessable Alley Paving Fund -- \$55,600; Nonassessable Alley Paving Fund -- \$15,000)

Whereas, The report of the Commissioner of Public Works has been filed with the City Clerk; and

Whereas, Notices have been sent to all interested persons and public hearings held; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances, and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That projects: N. 47th St. (ST21100116), Alley W. Melvina St. (ST212030104), Alley W. Capitol Dr. (ST212030122), N. Terrace Ave. (ST211020149), Alley W. Dakota St. (ST212030101), and Alley W. Euclid Ave. (ST212030125) will be billed after January 1, 2005, but not before 12 months after the project contract has been completed; and. be it

Further Resolved, That the following project be deleted from the 2003 Paving Program:
