This resolution amends Common Council File #110313 relative to application, acceptance and funding of the 2011 Public Health Preparedness (CDC) Grant from the State of Wisconsin-Department of Health Services. The purpose of the contract is to assure that the Milwaukee Health Department is ready to respond to emergencies including terrorism, pandemic influenza and other communicable disease outbreaks. These emergency preparedness and response efforts are intended to support the National Response Plan (NRP) and the National Incident Management System (NIMS).

Whereas, Common Council File #110313 authorized the Health Department to apply for, accept and fund the 2011 Public Health Preparedness (CDC) Grant from the State of Wisconsin-Department of Health Services.

This grant provided for a Grantor share total of \$331,629; and

Whereas, The Grantor share for this program has remained the same, however the budget has been amended; now, therefore be it

Resolved, By the Common Council of the City of Milwaukee, that application to the State of Wisconsin-Department of Health Services is authorized and the Health Department shall accept this grant without further Common Council approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it
