#### The Chair

Substitute resolution relative to the application, acceptance and funding of the 2012 Women, Infants and Children's (WIC) Grant from the State of Wisconsin Department of Health Services.

This resolution authorizes the Health Department to apply for, accept and fund the 2012 Women, Infants and Children's Grant project from the United States Department of Agriculture through the Wisconsin Department of Health Services in the amount of \$1,361,334. The purpose of the project is to prevent nutrition-related health problems and to improve the health status of low-income, at-risk pregnant or breast-feeding women, infants and children up to the age of five years.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the United States Department of Agriculture through the Wisconsin Department of Health Services for supplemental nutritious food and nutrition education; and

Whereas, The operation of this grant project from 01/01/12 to 12/31/12 would cost \$1,361,334 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Department of Health Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2012 Special Revenue-Grant and Aid Projects fund the following amounts for the program titled Women's, Infant's and Children's Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project level values; budget to these Project/Grant Values the amount required under the grant agreement; and, be it

- 2. Expend from the 2012 grant budget funds for training and out-of-town travel by departmental staff; and
- 3. Expend from the 2012 grant budget funds for specific items of equipment; and
- 4. Enter into subcontracts and leases as detailed in the grant budget; and, be it
