### THE CHAIR

A substitute ordinance to further amend the 2012 offices and positions in the City Service.

This substitute ordinance changes positions in the following departments:

Department of City Development, Health Department, Department of Neighborhood Services, Department of Public Works, Unified Call Center

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 1 of ordinance File Number 110441 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2012 - December 25, 2011):

Under "Unified Call Center", delete one position of "Communications Assistant IV" and add one position of "UCC Customer Service Representative IV"; delete ten positions of "Communications Assistant III" and add ten positions of "UCC Customer Service Representative III"; and delete six auxiliary positions of "Communications Assistant III" and add six auxiliary positions of "UCC Customer Service Representative III".

Part 2. Section 1 of ordinance File Number 110441 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 2, 2012 - January 8, 2012):

Under "Department of Neighborhood Services, eliminate the heading "Nuisance and Environmental Health Division".

Under "Residential Inspection Division, add one position of "Environmental Code Enforcement Manager (X) (Y)" immediately following the title "Building Codes Enforcement Manager (X)(Y)" and add the sections "Environmental Health Section" and "Operation Immediate Cleanup (A)" immediately following the section "Residential Rental Inspection Program".

Under "Department of Public Works, Operations Division, Sanitation Section, Field Operations", delete four positions of "Sanitation Worker" and add four positions of "Self-Help Yard Attendant".

Under "Water Works, Business Organization, Meter Services", add one position of "Program Assistant I".

Under "Unified Call Center", delete one position of "Communications Assistant III" and add one position of "Administrative Assistant II".

Part 3. Section 1 of ordinance File Number 110441 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 7, 2012 - March 18, 2012):

Under "Department of City Development, General Management and Policy Development Decision Unit, Real Estate and Development", add one position of "Program Assistant II (Y)".

Part 4. Section 1 of ordinance File Number 110441 relative to offices and positions in the City Service is hereby amended as follows:

Under "Health Department", amend footnote "(BBB)" to read as follows: "To expire 12/31/12 unless the Dual Protection Partnership Initiative from the State of Wisconsin Division of Public Health-Family Planning Program (DPH-FP) and the Family Planning Health Services, Inc. (FPHS, Inc.) is extended. Funds one position of Communicable Disease Specialist position in the STD Clinic. May partially fund one position of Nurse Practitioner position."

Part 5. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 6. The provisions of Part 1 of this ordinance are deemed to be in force and effect from and after Pay Period 1, 2012 (December 25, 2011).

Part 7. The provisions of Part 2 of this ordinance are deemed to be in force and effect from and after Pay Period 2, 2012 (January 8, 2012).

Part 8. The provisions of Part 3 of this ordinance are deemed to be in force and effect from and after Pay Period 7, 2012 (March 18, 2012).

The provisions of all other parts of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.

Part 9. This ordinance will take effect and be in force from and after its passage and publication.
